



Pursuant to Article 2.9, paragraph 1, point 2 of the Election Law of Bosnia and Herzegovina (Official Gazette of BiH, no. 23/01, 7/02, 9/02, 20/02, 25/02, 4/04, 20/04, 25/04, 52/05, 65/05, 77/05, 11/06, 24/06, 32/07, 33/08, 37/08, 32/10, 18/13, 7/14, 31/16, 41/20, 38/22, 51/22, 67/22 and 24/24) and Article 18 of the Rules of Procedures of the BiH Central Election Commission (Official Gazette of BiH, no. 32/23, consolidated text) the Central Election Commission of Bosnia and Herzegovina has at its 20th session held on May 3, 2024 adopted

DECISION

on the amount of remuneration for members of election commission of basic constituency in Bosnia and Herzegovina (Consolidated text)

Article 1

(Regular monthly remuneration)

(1) Members of the election commission of basic constituency shall be entitled to a regular monthly remuneration in the amount of 30% of the flat-rate allowance paid to the councilors in that constituency.

(2) Members of the election commission of a basic constituency that does not have a flat-rate allowance for councilors or where the allowance is not set as a fixed monthly amount but is tied to the duties performed by the councilor in the municipal council, the municipal assembly, or city council, as well as the number of meetings held, shall be entitled to a regular monthly remuneration for their work in the amount of:

- a) BAM 90 in basic constituency where up to 5.000 voters are registered in the excerpt from the Central Voters' Register,
- b) BAM 150 in basic constituency where up to 20.000 voters are registered in the excerpt from the Central Voters' Register
- c) BAM 210 in basic constituency where up to 50.000 voters are registered in the excerpt from the Central Voters' Register
- d) BAM 270 in basic constituency where up to 100.000 voters are registered in the excerpt from the Central Voters' Register
- e) BAM 350 in basic constituency where more than 100.000 voters are registered in the excerpt from the Central Voters' Register.

(3) Members of the election commission referred to in paragraph (1) of this Article shall receive remuneration as specified in paragraph (2) of this Article, in the established amounts and according to the number of registered voters in that basic constituency, if this is more favorable for them.

(4) The president of the election commission may be assigned a higher amount of remuneration compared to the remuneration established for the members of the election commission.

(5) The competent authority shall determine the amount of remuneration for the members of the election commission for each fiscal year, considering changes in the amount of allowances for councilors, the number of registered voters in that basic constituency, and the available funds of the municipalities/cities.

Article 2
(Remuneration in the election period)

(1) Members of the election commission of basic constituency in the election period shall be entitled to a monthly remuneration in the amount of 100% of the flat-rate allowance paid to the councilors in that constituency.

(2) Members of the election commission of a basic constituency that does not have a flat-rate allowance for councilors or where the allowance is not set as a fixed monthly amount but is tied to the duties performed by the councilor in the municipal council, the municipal assembly, or city council, as well as the number of meetings held, shall be entitled to a regular monthly remuneration for their work in the amount of:

- a) BAM 300 in basic constituency where up to 5.000 voters are registered in the excerpt from the Central Voters' Register,
- b) BAM 500 in basic constituency where up to 20.000 voters are registered in the excerpt from the Central Voters' Register
- c) BAM 700 in basic constituency where up to 50.000 voters are registered in the excerpt from the Central Voters' Register
- d) BAM 900 in basic constituency where up to 100.000 voters are registered in the excerpt from the Central Voters' Register
- e) BAM 1.100 in basic constituency where more than 100.000 voters are registered in the excerpt from the Central Voters' Register.

(3) Members of the election commission referred to in paragraph (1) of this Article shall receive remuneration as specified in paragraph (2) of this Article, in the established amounts and according to the number of registered voters in that basic constituency, if this is more favorable for them.

(4) The president of the election commission may be assigned a higher amount of remuneration compared to the remuneration established for the members of the election commission.

(5) The municipal council or the municipal assembly may award a monetary prize for exceptional work and dedication in the election commission, provided that the necessary financial resources are available in the budget for the current fiscal year.

(6) The competent authority shall determine the amount of remuneration for the members of the election commission for each fiscal year, considering changes in the amount of allowances for councilors, the number of registered voters in that basic constituency, and the available funds of the municipalities/cities..

Article 3
(Funds for execution)

In accordance with Article 1.2a, paragraph (3) of the Election Law of Bosnia and Herzegovina, the funds for remuneration referred to in Articles 1 and 2 of this Decision are provided for in the budgets of the basic constituencies. Payments are to be made simultaneously with the disbursement of monthly allowances for councilors in that basic constituency, and in cases specified in Article 1, paragraph (2) and Article 2 of this Decision, no later than the 15th of the current month for the previous month.

Article 3a
(Gender-neutral expressions)

Words that are, for the sake of clarity, listed in one gender in this Instruction refer to both male and female genders without discrimination.

Article 4
(Regulations covered by this Decision)

This Decision includes the Decision on the amount of remuneration for members of election commission of basic constituency in Bosnia and Herzegovina (Official Gazette of BiH, no. 27/22) and Decision amending Decision on the amount of remuneration for members of election commission of basic constituency in Bosnia and Herzegovina number: 05-1-02-2-572-1/24 of May 3, 2024.

Article 5
(Publication)

The Instruction shall be published in the Official Gazette of BiH, and shall be also published in the Official Gazette of FBiH, the Official Gazette of RS, and the Official Gazette of Brčko District of BiH and on the web site of the Central Election Commission of BiH www.izbori.ba.
