A) I shall maintain strict impartiality in the conduct of my duties;

- B) I shall not interfere with the electoral process, which includes registration of voters into the Central Voters' Register, polling day procedures or the vote count and I shall respect the secrecy of the vote;
- C) I shall not attempt to exert any influence over a person regarding his or her choice of voting options or the manner in which he or she will mark the ballot.
- D) I shall abide by the provisions of the Election Law of Bosnia and Herzegovina.

An observer may submit substantiated objections in writing regarding the work of the competent election management bodies established by the BiH Election Law. These objections shall be annexed to the minutes of the election management body's proceedings, upon which a political subject may file a complaint with the competent authority.
